



## **Gym Membership Agreement**

### **Gym Membership Agreement: Security Deposit Terms and Conditions**

#### **1. Security Deposit**

- To begin a 12-month gym membership, a security deposit of £105.00 (equivalent to 3 months' membership) is required.
- This deposit serves as security for unpaid dues, breaches of contract, or other outstanding obligations.

#### **2. Use of Security Deposit**

- Upon successful completion of the 12-month contract:
- The deposit will automatically be applied as credit for three consecutive months of gym membership at the contracted rate of £35.00 per month.
- Alternatively, you may request a refund of your deposit, subject to the Refund Policy (see Section 3).
- If the contract is terminated early or there are outstanding payments:
- The deposit will be used to cover unpaid fees or other liabilities.
- Any remaining balance can be refunded upon request (see Section 3).

#### **3. Refund Policy**

##### **- Eligibility for Refund:**

- Refunds are only available if all 12 monthly payments have been completed in full.
- Refund requests must be made in writing within 30 days of providing a written termination notice. Requests made after this period will not be honored.



#### - Process for Refund:

- Refunds will be processed within 14 business days of approval.
- A non-refundable administration fee of £15 may be charged and deducted from the security deposit to cover refund processing costs and closing membership accounts and any changes, if made to the membership (such as upgrades, downgrades, suspensions etc)

#### **- Conditions:**

- Refunds are not available if the security deposit has already been applied to cover outstanding payments or membership use (e.g., during the termination notice period).

#### **4. Membership Use During Termination Notice**

- If you attend the gym, book appointments, or otherwise use your membership during the 30-day termination notice period, the security deposit will automatically be applied as payment for that usage.
- In such cases, a refund of the deposit will no longer be possible.

#### **5. Early Termination**

- If the membership contract is terminated early (e.g., before 12 months are completed), the following will apply:
  - Any outstanding payments or fees will be deducted from the security deposit.
  - No refunds will be provided if the deposit is insufficient to cover the unpaid amounts.

#### **6. Important Notes**

- Deposit Expiry: Refund requests must be submitted within the 30-day termination notice period. Abi's Gym is not obligated to process refund requests made after this timeframe.
- Outstanding Balances: Refunds or credits will only be processed once all outstanding balances have been cleared.



- Fair Use Policy: The security deposit is not transferable or redeemable for cash and can only be applied or refunded under the terms of this agreement.

## 7. Your Rights and Obligations

- Transparency: All terms in this agreement comply with relevant consumer protection laws, including the Consumer Rights Act 2015.

- Data Protection: Abi's Gym is committed to protecting your personal information in accordance with applicable data protection regulations.
